All members of the SHOA are eligible to run for election to the BOD except:

- a. Families of members of the BOD whose position(s) on the BOD are not up for election. The goal is to ensure that under no circumstance can a Lot Owner family have more than one SHOA Member of their household serving on the BOD. While two members of a household may run for election to the BOD, only the one with the highest number of votes between them may be seated and serve on the BOD.
- b. Members of the Election Committee.
- c. Members who are in arrears to the SHOA for any financial obligation (annual dues, special assessments, adjudicated fines).
- d. Not be a convicted felon whose civil rights have not been restored for a period of at least 5 years nor have any pending felony level actions (i.e. indictments).
- e. Not be on a Sex Offender list.

A Board of Director (BOD) Candidate form has been provided with this notice to facilitate your running for a BOD position.

Completed candidate Forms must be returned electronically or via USPS no later than **Monday, October 19, 2020**. A list of the candidates will be distributed on October 24, 2020.
