

Release and Waiver of Liability

PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") executed on ___/___/___, by _____ ("Volunteer") in favor of Savannahs golf course, and its directors, officers, employees, contractors, and agents (collectively, "Savannahs Golf Course"). This Release is valid until 30 June _____ at which time it must be renewed for any future volunteer efforts.

The Volunteer desires to work as a volunteer for Savannahs Golf Course and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include landscaping and odd maintenance tasks, as well as rehabilitating some features on the golf course. Additional special duties include greeting golfers, starter duties – (issuing golf carts, cleaning golf carts, putting golf carts away, charging golf carts) and ball picking from the driving range and maintaining a clean and operational area for golfers.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver: Volunteer does hereby release and forever discharge and hold harmless Savannahs Golf Course and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Savannahs Golf Course. Volunteer understands that this release discharges Savannahs Golf Course from any liability or claim that the Volunteer may have against Savannahs Golf Course with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's Activity with Savannahs Golf Course whether caused by the negligence of Savannahs Golf Course or its officers, directors, employees, agents or otherwise. Volunteer also understands that Savannahs Golf Course does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical treatment: Volunteer does hereby release and forever discharge Savannahs Golf Course from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with Savannahs Golf Course.

Assumption of the Risk: The Volunteer understands that the Activities may be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Savannahs Golf Course from all liability for injury, illness, death, or property damage resulting from the Activities.

Insurance: The Volunteer understands that, except as otherwise agreed to by Savannahs Golf Course in writing; Savannahs Golf Course does not carry or maintain health, medical, or disability insurance coverage for any Volunteer.

Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.

Photographic Release: Volunteer does hereby grant and convey unto Savannahs Golf Course all right, title, and interest in any and all photographic images and video or audio recordings made by Savannahs Golf Course during the Volunteer's Activities with Savannahs Golf Course including but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other: Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by laws of the State of Florida, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Florida. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release which shall continue to be enforceable.
